Abstract

This report synthesises findings from 10 peer-reviewed papers addressing the following research question: How does differentially private low-rank reparametrization affect few-shot accuracy on the SuperGLUE benchmark compared to non-private baselines. 11 claims were extracted from source literature; 9 were independently verified against retrieved documents. An automated multi-reviewer quality assessment produced a score of 7.7/10. This report is a machine-generated literature synthesis and does not constitute original research.

1 Introduction
