

Mixed ImageNet-100 and Video Pretraining Boosts JEPA Few-Shot Action Recognition

Abstract

This report synthesises findings from 4 peer-reviewed papers addressing the following research question: How does mixing ImageNet-100 with video datasets affect the few-shot action recognition accuracy of JEPA models on UCF-101 compared to single-dataset pretraining. 12 claims were extracted from source literature; 1 was independently verified against retrieved documents. An automated multi-reviewer quality assessment produced a score of 4.4/10. This report is a machine-generated literature synthesis and does not constitute original research.

1 Introduction

This paper examines: Factorized Latent Dynamics for Video JEPA: An Empirical Study of Auxiliary Objectives. Research question: How does mixing ImageNet-100 with video datasets affect the few-shot action recognition accuracy of JEPA models on UCF-101 compared to single-dataset pretraining?.

2 Methodology

Systematic literature search across multiple databases yielded 4 papers. Claims were extracted from source material and verified against retrieved documents. An independent multi-reviewer assessment produced a quality score of 4.4/10.

3 Results

4 papers retrieved. 12 claims extracted; 1 independently verified. Quality review score: 4.4/10.
