

# Structural Complexity and Mixed Data Types in Tabular Generative Model Evaluation Metrics

## Abstract

This report synthesises findings from 12 peer-reviewed papers addressing the following research question: To what extent do structural complexity and mixed data types in tabular generative models limit the reliability of existing evaluation metrics compared to proposed novel measures. 10 claims were extracted from source literature; 4 were independently verified against retrieved documents. An automated multi-reviewer quality assessment produced a score of 6.1/10. This report is a machine-generated literature synthesis and does not constitute original research.

## 1 Introduction

This paper examines: Evaluating Generative Models for Tabular Data: Novel Metrics and Benchmarking. Research question: To what extent do structural complexity and mixed data types in tabular generative models limit the reliability of existing evaluation metrics compared to proposed novel measures?.

## 2 Methodology

Systematic literature search across multiple databases yielded 12 papers. Claims were extracted from source material and verified against retrieved documents. An independent multi-reviewer assessment produced a quality score of 6.1/10.

12 papers retrieved. 10 claims extracted; 4 independently verified. Quality review score: 6.1/10.
