

Adversarial Noise in Synthetic Data and Robustness of Tabular Foundation Models

Abstract

This report synthesises findings from 13 peer-reviewed papers addressing the following research question: To what extent does the inclusion of adversarial noise in synthetic training data affect the robustness of tabular foundation models on the TabMNAR benchmark, as measured by AUC score differences. 10 claims were extracted from source literature; 0 were independently verified against retrieved documents. An automated multi-reviewer quality assessment produced a score of 3.8/10. This report is a machine-generated literature synthesis and does not constitute original research.

1 Introduction

This paper examines: Robust Tabular Foundation Models. Research question: To what extent does the inclusion of adversarial noise in synthetic training data affect the robustness of tabular foundation models on the TabMNAR benchmark, as measured by AUC score differences?.

2 Methodology

Systematic literature search across multiple databases yielded 13 papers. Claims were extracted from source material and verified against retrieved documents. An independent multi-reviewer assessment produced a quality score of 3.8/10.

3 Results

13 papers retrieved. 10 claims extracted; 0 independently verified. Quality review score: 3.8/10.
