Existing evaluation metrics offer only partial insights, lacking a comprehensive measure of generative performance. To address this limitation, we propose three novel evaluation metrics: FAED, FPCAD, and RFIS. Our extensive experimental analysis, conducted on three stan

This paper examines: Evaluating Generative Models for Tabular Data: Novel Metrics and Benchmarking. Research question: How do the proposed novel tabular data evaluation metrics compare in accuracy and robustness against existing metrics when benchmarked across different generative models (e.g., CTGAN, TabPFN, TVAE) trained on heterogeneous financial and health-care datasets?.

## 2 Methodology

Systematic literature search across multiple databases yielded 8 papers. Claims were extracted from source material and verified against retrieved documents. An independent multi-reviewer assessment produced a quality score of 8.7/10.

## 3 Results

8 papers retrieved. 7 claims extracted; 7 independently verified. Quality review score: 8.7/10.
